

**State of Nebraska
Highest Paid Vendors and Personnel for Fiscal Year 2007
Summary**

the Auditor of Public Accounts.**

The Auditor of Public Accounts (APA) has prepared a summary of vendors paid over \$500,000 and personnel with gross pay of over \$100,000 from the State of Nebraska for the period of July 1, 2006 through June 30, 2007 (FY 2007). This information was summarized from the detailed information provided at the request of the APA by the Nebraska Information System (NIS) team and the University of Nebraska-Central Administration. The information was taken from the NIS - the State's business solution software system and Systems Applications and Products in Data Processing (SAP) - the University's business solution software system. Both of these systems are considered "live" systems, the information in our report includes data based on the date the data was retrieved from the systems. The funding for these payments comes from all fund types; General, Cash, Construction, Federal, Revolving, and Trust funds.

State Personnel with Gross Pay of Over \$100,000

Exhibit A is a list of all State personnel, excluding the University of Nebraska, with gross pay of over \$100,000 for FY 2007. The information was generated by the NIS team from NIS and summarized by the APA based strictly on the NIS address book number as provided from NIS. The listing reflects the name, job code description noted at June 30, 2007, total gross pay for FY 2007, and Agency. This information reflects the total actual gross pay received during the fiscal year and may include payments in addition to annual salary such as supplemental pay, vacation and sick leave payouts on retirement, and payments for legal settlements. We are aware of at least three instances where the employees listed on the chart received significant supplemental payments in addition to their salary, Jim Doggett, Dennis Loose, and Carla Schreiber. We noted 214 State personnel with gross pay of over \$100,000 for FY 2007 totaling \$26,070,413. **See Exhibit A.**

University Personnel with Gross Pay of Over \$100,000

Exhibit B is a list of all University personnel who received gross pay over \$100,000 for the FY 2007. The information was generated by the University of Nebraska from the University's SAP accounting system using the Personnel number as provided from SAP. The APA summarized the information and the listing reflects the name, primary position, and gross pay over \$100,000 for FY 2007. The "Primary Position" column indicates the position title at fiscal year end. As a result, if an individual retired before June 30, 2007, their primary position is noted as "Retiree." This information reflects the total actual gross pay received and may include payments to employees in addition to salary such as is explained above with respect to state employees. We noted 1,063 University personnel with gross pay over \$100,000 for FY 2007 totaling \$146,171,993. **See Exhibit B.**

Vendors Paid Over \$500,000 from the State of Nebraska


Exhibit C is a list of vendors who were paid over \$500,000 for FY 2007. This information was generated from information provided by the NIS team from NIS. The original information provided from NIS included the vendor paid; Federal Tax Identification Number (FTIN), NIS address book number, and NIS address book type. For this listing, the APA excluded all payments to political subdivisions and tax return related payments. The APA totaled the amounts paid to vendors by using the FTIN number as recorded in NIS to get the total paid for FY 2007 to each vendor. The APA

noted there were numerous payments with no FTIN number or incorrect FTIN numbers on the information received, the APA did not adjust the numbers and are strictly reporting the paid amounts based on the FTIN number reported from NIS. This report includes only the vendor name as identified by the NIS address book. In the cases where multiple address book numbers were assigned to the same vendor with varying names, the APA judgmentally selected the most prominent name or a combination of the names to report. The payment amounts are for various reasons, excluding tax refunds. The APA judgmentally determined the most prominent payment description or a combination of such to be included in the general payment description column of the exhibit, it is not all inclusive. We noted 854 vendors receiving total payments over \$500,000 in FY 2007 totaling \$3,461,803,851. **See Exhibit C.**

Political Subdivisions Paid Over \$500,000 from the State of Nebraska

Exhibit D is a list of political subdivisions paid over \$500,000 which were initially withheld from Exhibit C. The information was prepared in the same manner as Exhibit C with the exception that no payment descriptions were included. This report includes only the vendor name as identified by the NIS address book. In the cases where multiple address book numbers were assigned to the same entity with varying names, the APA judgmentally selected the most prominent name or a combination of the names to report. We noted 516 political subdivisions receiving total payments over \$500,000 in fiscal year 2007 totaling \$2,264,230,939. **See Exhibit D.**
